If inhaled	: No treatment necessary under normal conditions of use. If symptoms persist, obtain medical advice.

Local anaesthetics or hot soaks should be avoided because they can contribute to swelling, vasospasm and ischaemia. Glove thickness is not a good predictor of glove resistance to a chemical as it is dependent on the exact composition of the glove material. Glove thickness should be typically greater than 0.35 mm depending on the glove make and model.
